HMHB endeavors to improve the health, safety and well-being of Montana families by supporting mothers and babies age zero to three.

Essentials for Baby: This program includes Safe Sleep and Safe Seat. We provide cribs and car seats to high risk families and promote child wellness and safety. For the year ended 6/30/20, we distributed 591 cribs and 331 car seats. A new component allows us to provide essential personal care items for babies and mothers. We distributed over 22,000 diapers, 5300 menstruation supplies, 720 nursing pads, 192 packs of 100 wipes, 69 thermometers, 100 masks, and 200 hand sanitizer bottles.

Maternal Mental Health: Increase awareness of Perinatal Mood and Anxiety Disorders and Perinatal Substance Abuse Disorders. HMHB works with community-based perinatal support coalitions to address maternal mental health issues in their communities. Children require safe, stable, nurturing relationships and environments (SSNRs). By ensuring SSNRs are in place, chances of abuse, neglect, and poor child health and social outcomes are decreased. We also sponsored the virtual Perinatal Mental Health Conference over 5 days. Topics included: impact of the pandemic on maternal mental health, paternal perinatal mental health, substance use disorders in pregnancy, and indigenous perinatal mental health. Over 250 people registered for the conference and average daily attendance was 175.

MT ECC: Coordinate the 21 local early childhood coalitions in Montana to provide opportunities for shared professional development, joint advocacy, parent engagement, peer sharing, and statewide collaboration for the work being done to promote optimal early childhood development and family stability and security across the state. Continue to advance Montana's efforts to improve maternal and child health and early childhood development by increasing access to data at the state and local level.
