THE ESSENTIALS FOR BABY PROGRAM PROVIDES SAFE SLEEP ENVIRONMENTS, CAR SEATS, SUPPLIES, AND EDUCATIONAL MATERIALS AT NO COST TO FAMILIES ACROSS THE STATE. WHEN A FAMILY IS IDENTIFIED, LOCAL PUBLIC HEALTH DEPARTMENTS OR EARLY CHILDHOOD SPECIALISTS AT HOSPITALS, INDIAN HEALTH SERVICES PROGRAMS, OR NONPROFIT ORGANIZATIONS MAY SUBMIT A REQUEST TO THE ESSENTIALS PROGRAM TO PROVIDE NECESSARY ITEMS AND EDUCATIONAL MATERIALS. THE ESSENTIALS PROGRAM OFTEN OPENS THE DOOR TO OTHER SUPPORTIVE SERVICES, SUCH AS HOME VISITING, WIC, LACTATION COUNSELING, AND HEALTH CARE. ESSENTIALS CONNECTS HMHB TO THE NETWORK OF SUPPORT FOR MONTANA FAMILIES.
